Re: **Demand for Proof of Authority - Quo Warranto**

Mary:

I am writing to you on behalf of all Canadians, whom I believe you are familiar with, as you fashion yourself as the British monarch's representative in our country.

The nature of this communication is a demand for you to provide unambiguous proof of your legal standing, as you are currently occupying the role of the Governor General of Canada.

Our understanding, and the information available, lead us to question the legitimacy of your occupation. Therefore, in accordance with this Writ of Quo Warranto, we demand proof of your lawful assumption of this office.

As you should know, a writ of Quo Warranto is an ancient and respected instrument within the Common Law tradition of our nation. This legal instrument appropriately applies to public officials and is intended to prevent the unlawful exercise of duties by an individual who does not possess the lawful authority to execute said duties.

As per this Writ, it has come to our attention that you may have assumed the position of Governor General of Canada without legitimate authority; commonly termed as being a 'pretender' to the office. Canadians have suffered considerable damages since the beginning of your "occupation" of this role. We have been viciously attacked by your de facto Trudeau government, with the illegal invocation of the Emergency Act.

Peaceful protesters were beaten by your troops; your horses, ridden by mercenaries, trampled Canadian citizens in the streets of Ottawa, causing, at least in one case, death. You have allowed political prisoners to be held for years, without bail, in Coutts, Alberta. And *your* government now wants to jail us, for life, for invoking our God-given right to free speech with Bill C 63.

If you are the rightful Governor General, and you allowed this to happen, you have not fulfilled your only duty, which is to assure the government respects common law; and you will be held to account. If you are not, then you are complicit, and will be held to account for treason.

What we require from you, is for you to produce the Royal Writ of Authority that validates your ascent to the office of Governor General within ten (10) business days from the signatory date. This will include the Letter Patent, from the monarch, containing your duties and orders.

If you are unable or unwilling to provide satisfactory proof, we regret to inform you that we will initiate necessary legal proceedings, without further notice, to uphold the integrity of this position, and to mitigate the potential damages that may result from an illegal assumption of power. This will, among other actions, include the invocation of Section 27 of the USMCA - the United States, Mexico, Canada Treaty, which came into effect on July 1, 2020, and binds all signees.





PREAMBLE/PREFACE

- 5)** It must have some permanency and continuity and not be only temporary or occasional. In addition, in this state, an officer must take and file an official oath, hold a commission or other written authority and give an official bond, if the latter be required by proper authority.

Definitions, Words, Terms and Conditions used in this instrument:

AUTHORITY means: Permission. Control over jurisdiction. The term is often synonymous with power. The power delegated by a principal to his agent. The lawful delegation of power by one person over another. Power of agent to affect legal relations of principal by acts done in accordance with principal's manifestations of consent to agent

BIBLE means: King James 1611 version

COGNIZANCE means: Jurisdiction, or the exercise of jurisdiction, or power to try and determine causes; judicial examination of a matter, or power and authority to make it.

JURISDICTION means: It is the authority by which courts and judicial officers take cognizance of and decide cases. It exists when court has cognizance of class of cases involved, proper parties are present, and point to be decided is within issues. It is of three kinds: personal, territorial and subject matter:

Personal Jurisdiction is the authority over a person, regardless of his/her location.

Territorial Jurisdiction is the authority confined to a bounded space, including all those present therein, and events which occur there.

Subject Matter Jurisdiction is the authority over the subject of the legal questions involved in the tribunal for professional misconduct.

QUO WARRANTO means: A writ, in the nature of a writ of right for the king/queen, against him/her who claimed or usurped any office, franchise, or liberty, to inquire by *what authority* he/she supported his/her claim, in order to determine the right.

“The plaintiff in Quo Warranto is not required to allege any facts in the complaint showing that the challenged acts are unlawful. It is enough to allege the exercise of the right without lawful authority. All that is necessary or material in any count of the complaint is the general charge of usurpation. The defendant must either disclaim or justify. If he justifies he must set out facts which show his lawful authority to exercise the right claimed... The plaintiff is not required to either allege or prove any facts. The right to call upon any person, natural or artificial, by Quo Warranto, to justify his acts, is an incident of sovereignty. The burden is on the defendant. If he attempts to justify he must allege and prove facts which justify his acts. Such facts when alleged may be rebutted. The defendant, not the plaintiff, must, by his answer, tender the issues on

which the rights claimed by him are to be litigated....The office of an information or complaint in the nature of Quo Warranto is not to tender an issue of fact, but only to call upon the defendants to show by what authority they claim the right to exercise the powers alleged to be usurped....In other litigation the complaint tenders the issues. It is only in rare instances that the issues tendered by the complaint, in so far as the plaintiff's case is concerned, are departed from. This is not true in Quo Warranto proceedings. In such cases the issues are never tendered by the complaint. They are tendered for the first time by the answer of the defendant.”

PARTIES means: The Plaintiff and Defendants identified on this instrument.

RESPONDEAT-SUPERIOR means: Let the master answer. This maxim means that a master is liable in certain cases for the wrongful acts of his servant, and a principal for those of his agent.

WRIT means: In Scotch Law. A writing, an instrument in writing, as a deed, bond, contract, demand.

It has come to the attention of the plaintiff that this tribunal is operating beyond both its scope of AUTHORITY and JURISDICTION. I conditionally accept your presumed authority upon proof of claim, as outlined in this instrument.

FACTUM

British North America Act 1867:

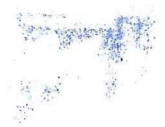
Queen Victoria enacted the British North America Act on 29th March 1867: "The Provisions of this Act referring to Her Majesty the Queen extend also to the Heirs and Successors of Her Majesty, Kings and Queens of the United Kingdom of Great Britain and Ireland." Without notice or answer, signed under the penalty to be true correct and materially complete, the Parties agree to this fact.

The Statute Law Revision Act, 1893 [56-57 Victoria, c. 14 (U.K.):

Enacted on 19th June 1893 "which may be regarded as spent, or have ceased to be in force otherwise than by express specific repeal by Parliament, or have, by lapse of time or otherwise become unnecessary should be expressly and specifically repealed." **The British North America Act 1867 is repealed.** Without notice or answer, signed under the penalty to be true, correct and materially complete, the Parties agree to this fact.

CANADA ACT 1982:

An Act to give effect to a request by the Senate and House of Commons of Canada[1]. "Now Know You that We, by and with the advice Our Privy Council for Canada, do by this Our Proclamation, declare that the Constitution Act, 1982 shall, **subject to section 59 thereof**, come into force on the seventeenth day of April in the Year of Our Lord One Thousand Nine Hundred and Eighty-two." Section 59 defers to section 23 (of the Constitution Act). Section 23 concerns itself with the issue of language. Section 59 / 23 is the condition* for which the Constitution of 1982 will come into force and effect. As this has yet to happen, at the current time the constitution has **no force and effect.** Without notice or answer, signed under the penalty to be true, correct and materially complete, the Parties agree to this fact.



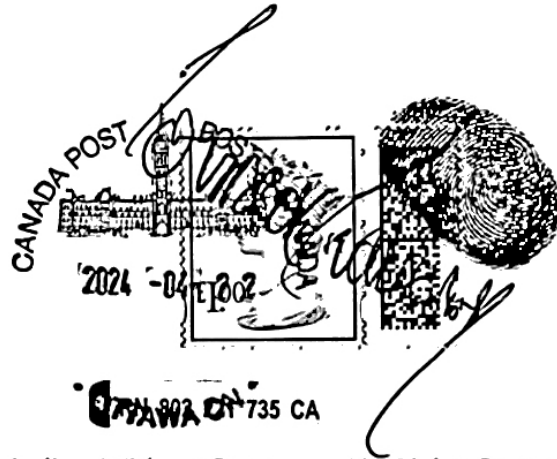

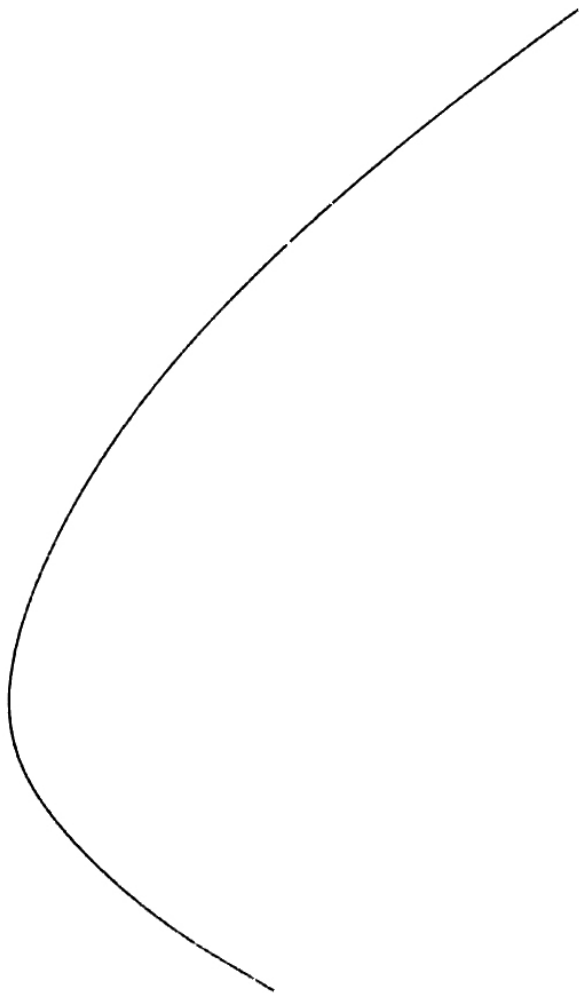
